

Rosemount Branch Update

2026 MY CREDIT UNION Scholarship Applications Are Live

MY CREDIT UNION 2026 Scholarships are live! 4 deserving high school seniors will be awarded \$2,500 in scholarships to be used for any post-secondary degree (college, trade school, etc.)

Eligibility requirements include:



- Primary membership at MY CREDIT UNION prior to January 1st, 2026.
- Must be a high school senior at the time of the application and awarding of the scholarship.
- Maintain primary MY CREDIT UNION membership through the award period.
- Must be a member in good standing to be considered and to receive the award.
- Previous MY CREDIT UNION Scholarship Award Winners and MY CREDIT UNION employees and family members are not eligible to apply.

Deadline for applications to be received/postmarked is March 28, 2026. Scholarship winners will be announced at the 69th Annual Meeting on Monday, April 27, 2026.

Medicare Planning for 2026: Stay Ahead and Covered

Why It Matters?

Enrollment during your Initial Enrollment Period (IEP) ensures:

- Seamless coverage starting at age 65
- Avoidance of late penalties associated with missing your enrollment window



The Initial Enrollment Period (IEP) lasts for 7 months, starting 3 months before you turn 65 and ending 3 months after your birthday month

Turning 65 in 2026? Check out the Medicare Enrollment Timeline to help you plan!



What You Should Do Now

1. Identify your 65th birthday month
2. Mark your calendar for **three months prior** – that's the earliest you can schedule a Medicare Planning Appointment
3. Reach out to TruLync Medicare Advisors well before then to reserve your spot – it's the best way to guarantee a smooth transition.
4. Make note of any questions that you have in various plan options, prescription drug coverage, specific paperwork to bring to your Medicare Planning Appointment.
