Back-To-School Scams May Be on the Rise

Scammers may prey on the busy lives of students and parents that are getting ready for a new school year, taking advantage of the expected letters, emails and text messages from schools.

Be on the lookout for these scams:

Messaging: Schools and teachers often communicate via third-party apps that will send messages from a consistent phone number or email address. If you ever feel like the message is odd or inconsistent, reach out to the school or individual through a trusted contact number.

Textbook Shopping and School Supply Discounts: Schools will often provide information on where to purchase school supplies and textbooks. Visit those websites directly and make sure any links you click are provided by trusted sources from the school. Never trust offers that are "too good to be true."

Prospective College Students and Scholarships: Be aware of where you are looking for scholarships, or you may come across a fake scholarship and send personal information. Scholarship information is typically provided by schools, or you may find trusted third parties that offer scholarships, such as MY CREDIT UNION.

Post-Secondary Scams: Always be cautious when communicating with prospective employers or roommates. Verify who they are by visiting secure websites for the employer or confirming that the roommate is enrolled with the school.

The key to preventing fraud is to always be cautious, ask questions, verify the individual or company you are working with and never rush through the vetting process or make a hasty decision.
