The Supervisory Committee acts on behalf of the MYCU membership as the guardians of the members' interest and rights and carry out a continuing series of checks up to ensure that records are maintained properly, honestly, and accurately; that those policies established by law and by the board of directors are carried our faithfully; and that members concerns are promptly addressed and resolved.

Time Commitment

Eligibility Requirements

- A member in good standing at MYCU for a minimum of one (1) year
- At least 18 years of age
- Must be able to pass a background check (credit and criminal) and be bondable
- Must be able to meet the time commitments listed above
- Ability and willingness to learn and use an iPad or laptop for board packet distribution
- Ability to sign on to a secure website with login and password
- Ability to meet requirements in job description

To avoid potential conflicts of interest, MYCU employees, their immediate family members and employees, officers, or directors of any another financial institution are not eligible to serve on the MYCU Supervisory Committee.
