A minimum of five MYCU members serve on the Board of Directors at any given time. Board Members serve for a three-year term and may apply for re-election at the end of each term. As a not-for-profit financial institution, MYCU is focused on responsible and sustainable growth, while returning value to its members in the form of competitive rates, full-service products and investing in the communities we serve.

Successful MYCU Board of Director candidates tend to be those with a strong commitment to the communities served by MYCU and a willingness to help your credit union grow and succeed.

The Board of Directors acts on behalf of the MYCU membership who elected them to safeguard member financial interests by establishing and enforcing policies that will lead to the betterment of MYCU. Direction is provided to the Board of Directors by the National Credit Union Administration (NCUA), State of Minnesota regulations, and sound business practices.

- Must be able to meet the time commitments listed above
- Ability and willingness to learn and use various forms of technology to access board information
- Ability to meet requirements in job description

To avoid potential conflicts of interest, MYCU employees, their immediate family members, and employees, officers, or directors of any other financial institution are not eligible to serve on the MYCU Board of Directors.
