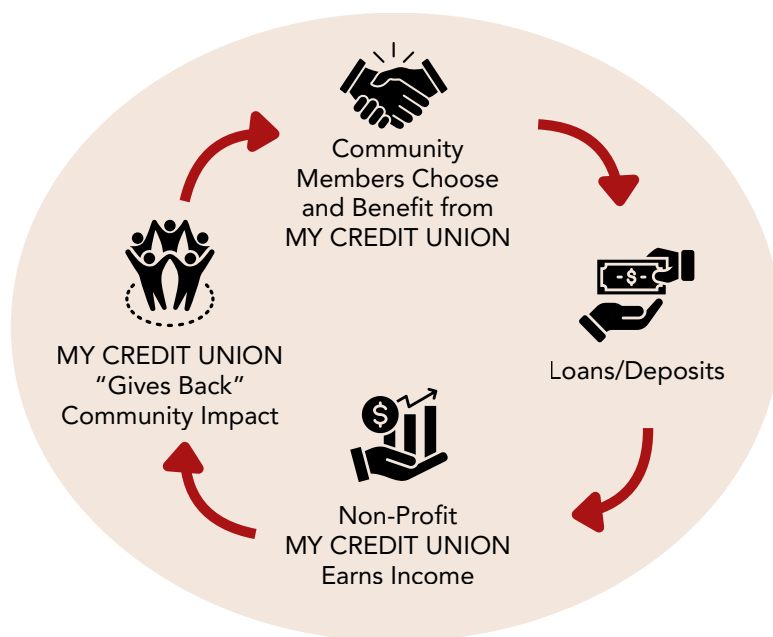

5th Annual Corporate Cornhole Tournament

As many members know, MY CREDIT UNION is the primary corporate sponsor/supporter of Flags for Fort Snelling (FFFS). 2026 marked the 10th anniversary of that relationship. What most members may not realize is that a local veteran saw us on TV for FFFS back in 2019 and asked us to help his organization, Warriors Next Adventure, which helps veterans with PTSD find positive outlets and support.

So, at the end of the global pandemic in 2022, the MY CREDIT UNION Community Foundation launched its inaugural "Fall Classic" Corporate Invitational Cornhole Tournament and in four years has raised over \$250,000 for local veteran organizations. The focus is on having fun while raising as much money as possible! Professional cornhole players are discouraged from participating...



The event has drawn over 128 two-person corporate teams each of the first four years, but there is always room for more!
